BRIEF HISTORY OF WEST CENTRAL DISTRICT

In November 1955 a representative group of Michigan Association of Hospital Auxiliaries met in Grand Rapids to organize the West Central District. Mrs. Harry F. (Sally) O'Malley, St. Mary's Hospital Auxiliary, Grand Rapids, was appointed chairman.

West Central District was then organized and the first meeting was held February 10, 1956 at The Women's City Club in Grand Rapids. Seven hospitals were represented: Greenville, Ludington, Holland, Zeeland, Blodgett, Butterworth and St. Mary's.

The district has grown rapidly since that first meeting. It began with seven participating auxiliaries and there were sixteen with a combined membership of approximately 4,000 encompassing thirteen counties at one time. The counties included Kent, Ottawa, Muskegon, Ionia, Mecosta, Montcalm, Oceana, Newaygo, Mason, Lake, Osceola, Allegan and Van Buren.

Michigan Association of Hospital Auxiliaries was first organized in the fall of 1948. The first president of MAHA (Oct. 1949-Nov. 1950) was Mrs. William (Dorothy) Schmitz from Allegan General Hospital, West Central District.
